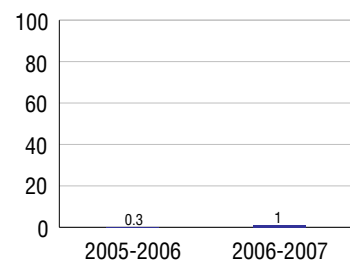

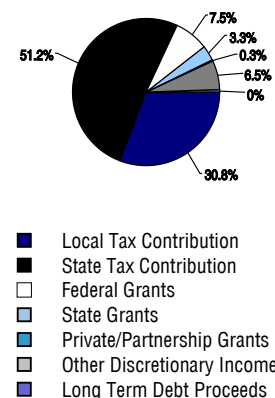

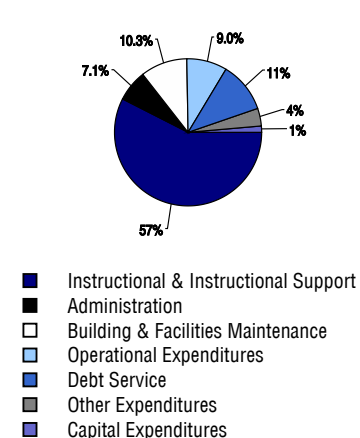

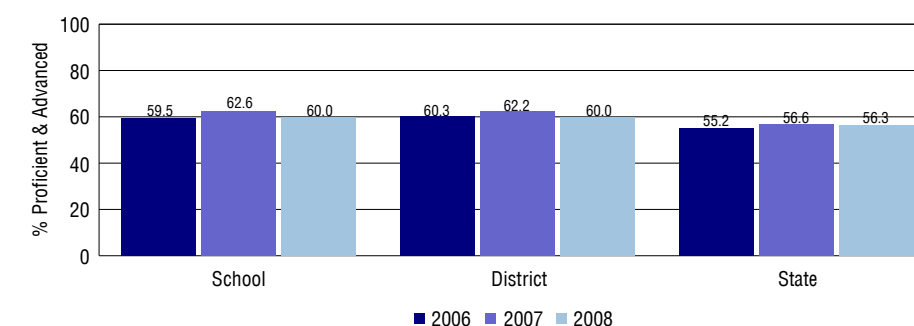
Overall Academic Performance on State Assessments

Each school in the State received a rating of "Excellent", "High", "Average", "Low", or "Unsatisfactory" for student academic performance based on 2007-2008 CSAP and COACT results. The rating is calculated using weighted percentages of each CSAP proficiency level for all content area and grade results for the school, as well as average COACT Reading, Writing, and Math Grade 11 results.

Academic Growth of Students

Each school in the State received a rating of "Low", "Typical", or "High" for student academic growth based on CSAP results. The calculation method is new for 2007-2008. Percent Proficient and Advanced for Middle Grades for All Content Areas



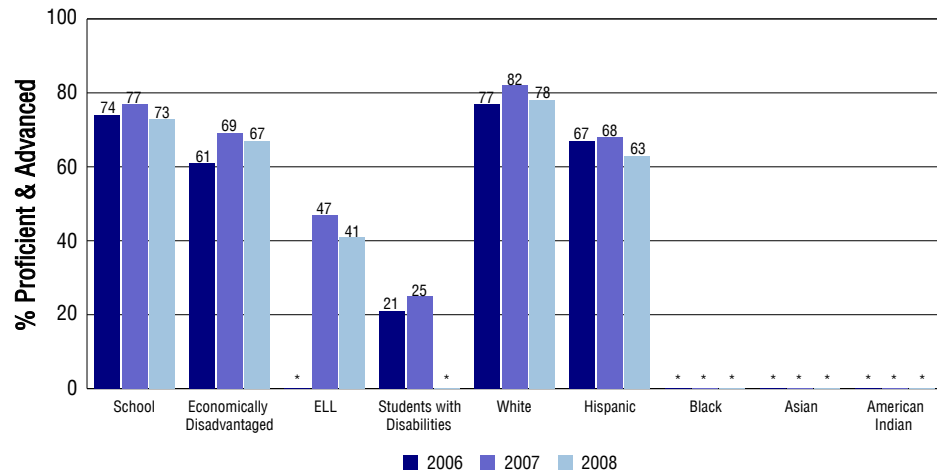

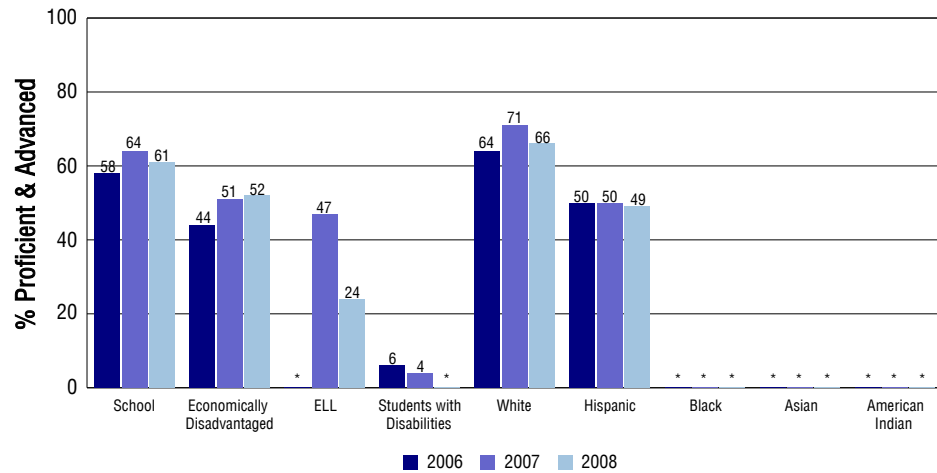
STUDENT PERFORMANCE

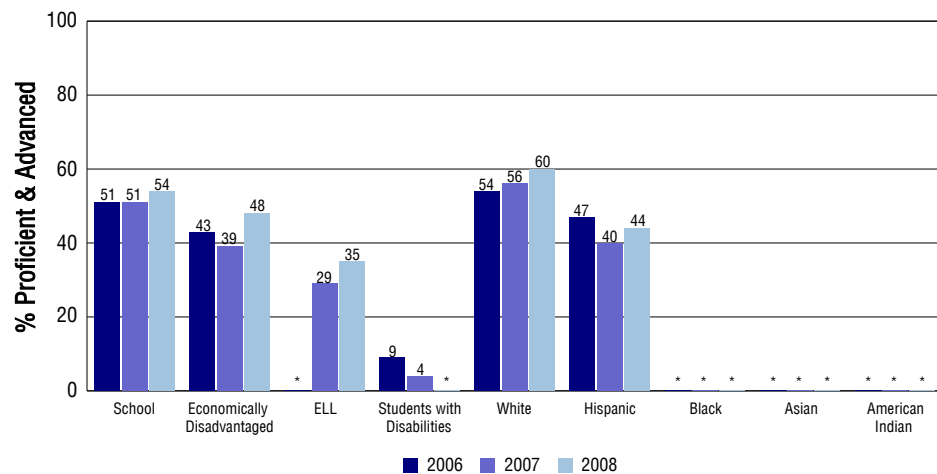
Reading

- Pleasant View is a family learning atmosphere where kids come first; Putting Respect In Diverse Education.
- Outstanding community outreach programs with award winning food drive, community healthy heart race, and scholarship recipients of over \$10,000 annually.

School Goals (as submitted by your district)

Pleasant View Middle School has three academic goals for reading, writing, and math. All children will gain a minimum of one year of achievement for one year in school as measured by a longitudinal assessment of CSAP results in reading, writing, and math. Additionally, the staff works to close achievement gaps between groups of students. We support these goals with a strong literacy program and library materials, Accelerated Reading Program/Star Reading assessments, the Successmaker program, 6 trait writing, curriculum mapping, and teacher inservice preparation. Parents are able to track student performance and attendance online.
